The Pledge of Allegiance was recited.

Minutes from June 15, 2023 were reviewed:

• MOTION: Kim Queen made a motion to approve the minutes, second by Dale Wiegand; minutes were unanimously approved.

Assistant Deputy Secretary Joseph Hoey provided an agency update to the Council:

- Passed along Secreatary-designee Bond's thanks and appreciation for their flexibility in relation to change of meeting date and location from September 21,2023 (King Veterans Home) to October 12, 2023 (Wisconsin Veterans Museum).
- Tour of King Veterans Home Moses Hall will be rescheduled to Spring 2024

Assistant Deputy Secretary Joseph Hoey provided a legislative update to the Council:

- Bills currently moving through Legislature which will change the law eliminating the need for those
 applying for CVSO positions to take the Civil Service Exam and allowing spouses of veterans to be
 admitted to one of three nursing homes if their spouse is not already a member or resident.
- 2023 Senate Bill 251/Assembly Bill 231, removing inactive groups from statutes establishing membership of COVP and adding three reps from student organizations.
 - MOTION: Paul Fisk made a motion to support the Bill, second by Michael Furgal; COVP support
 of Bill unanimously approved.

Administrative Update provided by Dawn LaFond:

- Records training and ethics training are due by November 17, 2023
 - There is an online records training that will satisfy requirements and is available October 25 at 9am and October 26 at noon.
- There is a free screening of Dear Sirs at the Sun Prairie Marcu Palace Cinema located at 2830 Hopeker Road at 6:00pm on Thursday, October 12, 2023.

Cal Stammer, Supervisor for the Veterans Outreach and Recovery Program provided updates on Program:

- VORP regions have been expanded from 11 to 16 coordinators which was funded by ARPA dollars through December 2024, allowing for better quality case management.
 - If no additional funding is received, then regions will revert to 11 regions/coordinators.

 Paul Fisk informed the Council that he is working with Representative Riemer and will provide an update to Council at next meeting.

Master Plan Study Update:

 ACTION: Each organization to provide recommendations to ADS Hoey with respect to what should be included in the RFP study as it relates to long-term care needs of veterans in all three Wisconsin State Veterans Homes.
